



Sub: Grant of provisional affiliation/recognition to the Newly proposed Maharastra Partap National College, Mullana(Ambala) w.e.f. the Academic Session 1983-84 Fulfilment of Conditions.

Dear Sir,

In continuation of this office Endst. No. CBR/MPNC/M/83/3275 dated 12.8.1983, on the subject cited above, I am desired to inform you that the recommendations made by the Inspection Committee for starting the Newly proposed College by your Society/Management have been accepted by the Executive Council of this University vide its Resolution No. 102 dated 12.9.1983 and consequently has granted provisional affiliation/recognition to MAHARANA PARTAP NATIONAL COLLEGE, MULLANA(AMBALA) allowing it to start the Arts and Commerce faculties i.e. Pre-University(Arts) and B.A.Part-I Classes with the Subjects of English, Hindi, Sanskrit, Economics, History, Pol.Sc./ Civics, Music(Vocal) & Punjabi & Prep(Commerce) class one Unit of Eighty(80) students w.e.f. the current Session i.e. 1983-84, in the first instance only, subject to the fulfilment of the following conditions:

1. The Management of the College shall abide by the conditions imposed by the Haryana Govt. vide its letter No. 22/21/83-Edu. I(2), dated 26.7.1983, say, construction of the Building etc. within the specified period of two years.
2. The College Management shall make provision for the regular building of the College (for which it shall supply the approved plan to the University), as the present Building of the College is improvised one, but sufficient for the time being.
3. There shall be a provision for Play grounds and acquire basic sports material for Games-Volley-Ball, Badminton, Table Tennis & Foot-Ball etc.
4. The College should make provision of requisite number of Type-writers of their own @ One Typewriter for every batch of four students.
5. The College Management should purchase good books, i.e. Texts, as well as general, equal to the value of Rs 10,000/- and should in no case, subscribe to cheap notes etc.
6. The Management should develop the surroundings of the College by laying out Lawns and proper demarcation and development of Play fields.

7. INTD. The appointments of requisite qualified staff i.e. Principals, Lecturers as per requirements, D.P.E., as well as Librarians etc. shall be made at the earliest, after adopting the procedure as laid down under the rules.
8. In addition to the above, one Type-Instructor shall be also appointed.
9. The College Management shall purchase the required Items of Furniture worth Rs 25,000/-.
10. Provisional recognition/affiliation is only for the year i.e. for the academic session 1983-84, in the first instance subject to another inspection early next session i.e. (at the start of the next Session 1984-85), so that it could be assessed what arrangements the College Management has made during the Academic Session 1983-84, with regard to fulfilment of the above conditions.

You are requested to take immediate steps with regard to the fulfillment of the conditions under early intimation to this effect and acknowledge the receipt of this letter.
